

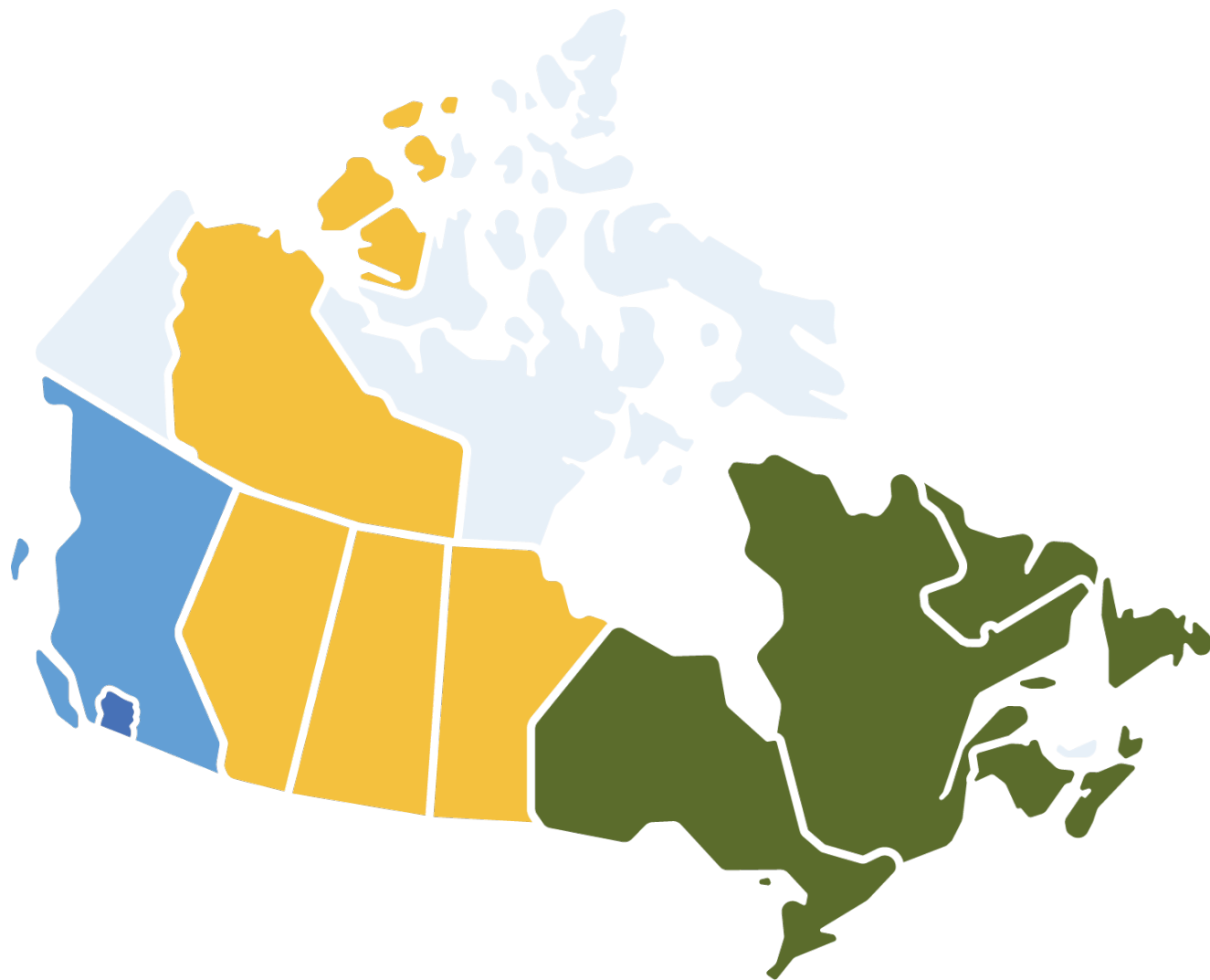

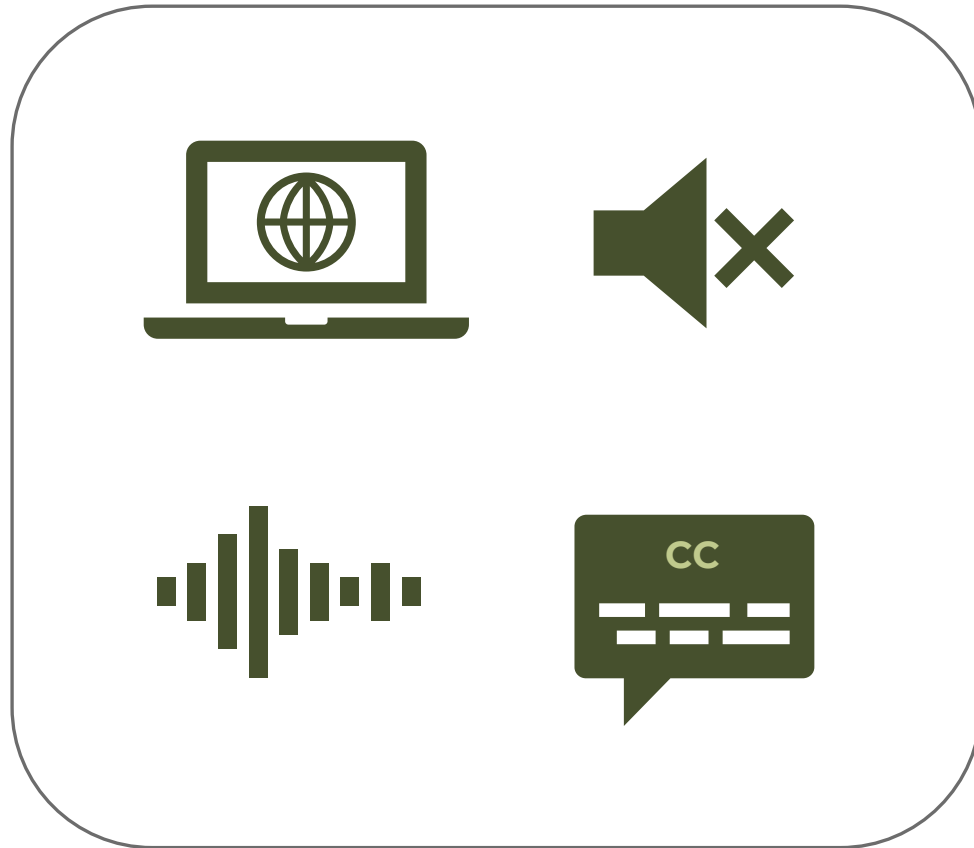

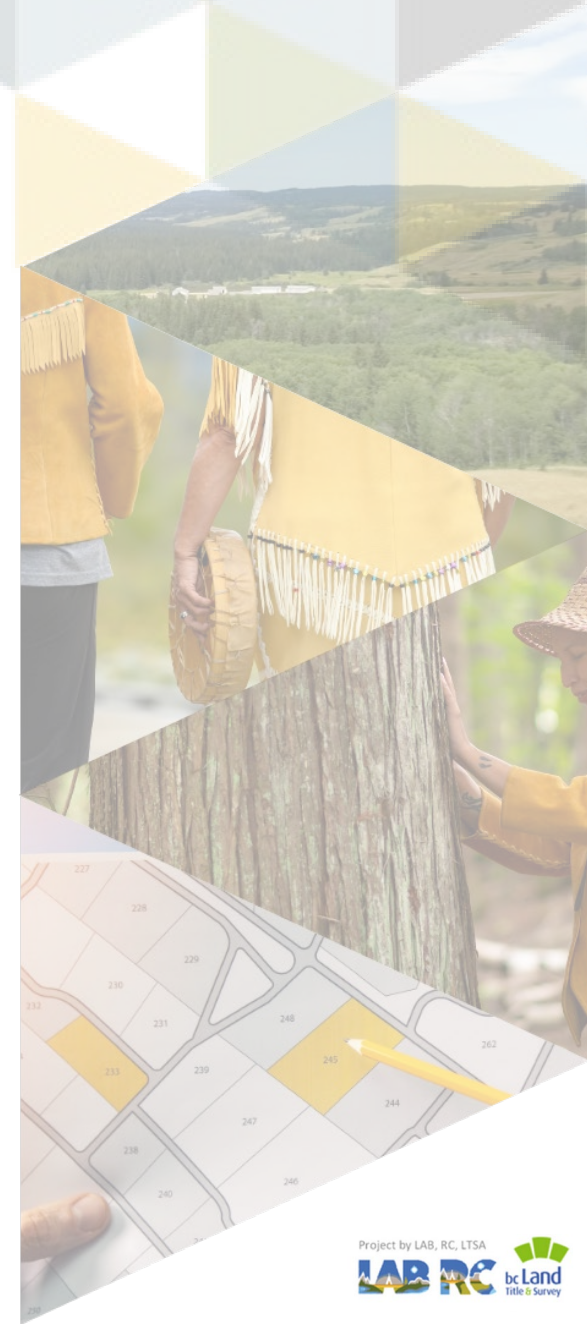

# A Solid Foundation - Program Achievements in 2025

- **FNLGR Inc.** incorporated and the corporation formally established
- **Board of Directors** installed
- **Registrar's Office and core FNLGR team in place**, with a Deputy Registrar and Financial Controller recently onboarded
- **Key future roles defined**, including the Survey Advisor and other operational positions, with job descriptions drafted and recruitment underway
- **Pilot First Nations** selected and announced, confirming the initial cohort that will be first to move their land transactions from Canada's registry to the FNLGR
- **Pilot engagement** launched regular meetings with pilot land teams to map their transition path and expectations
- **Pilot data imported** into the new registry, including activation of the first pilot Nations in the test environment
- **Initial data-enhancement passes completed** on pilot data to identify problem layers and clean up legacy records ahead of launch
- **New survey process implemented with SGB**, updating survey workflows and forms to align with FNLGR and future parcel fabric
- **Build and development work has progressed significantly**, with core registry functionality, integrations and workflows moving toward launch readiness
- **Economic benefits study for FNLGR** in final stages of review, supporting the long-term funding and value-for-money case with Canada
- **FNLGR Regulations subjected to detailed review**, including in-person sessions with the FNLGR legal team and an external "legal think tank" review
- **Governance & policy groundwork advanced**, with work on must-make policies and privacy tools to support launch
- **National engagement**, ramped up regional open houses, focus groups and webinars, conferences and gathering feedback from communities

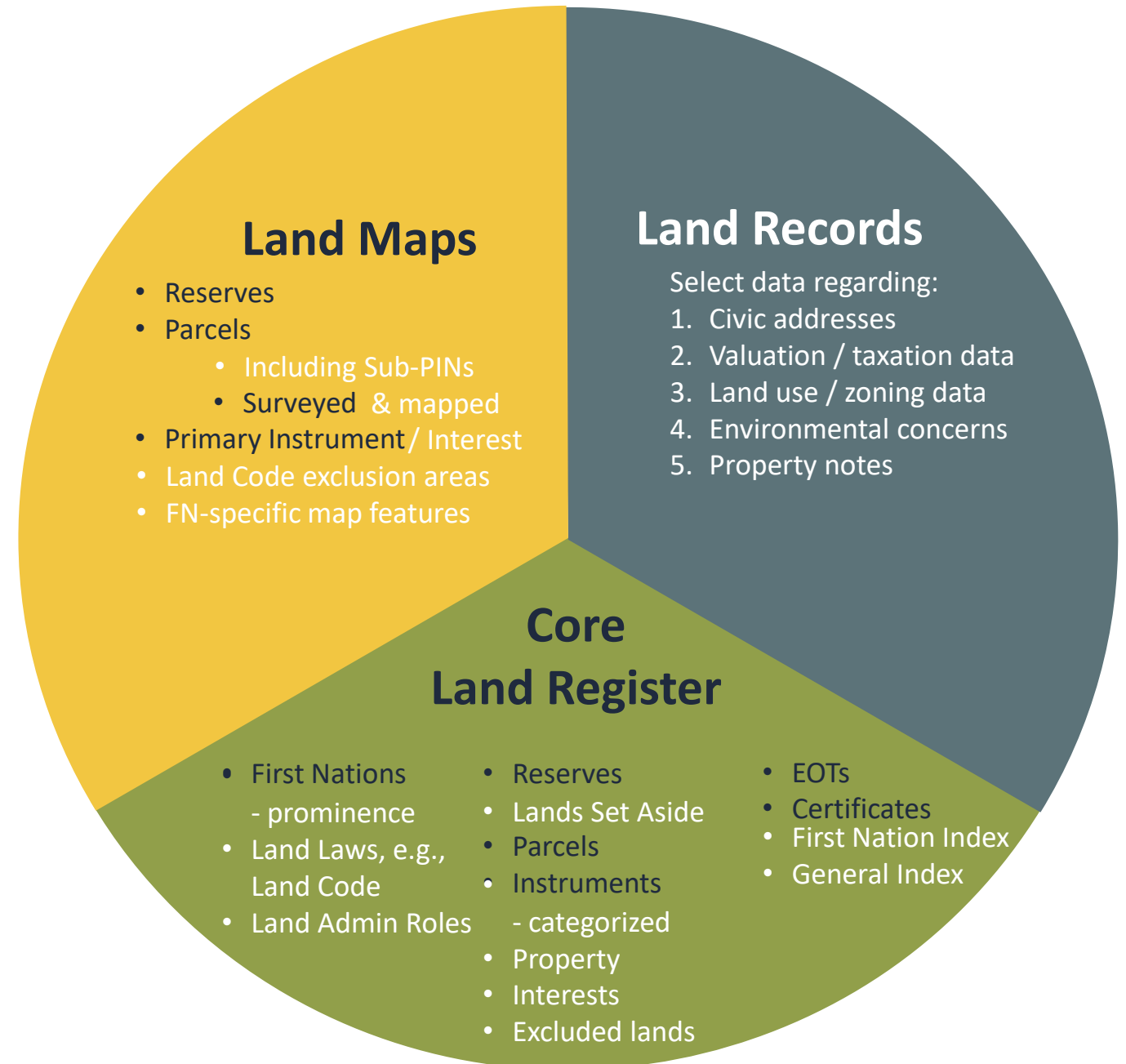
# The Year Ahead - Target Milestones in 2026

- ❖ **Make FNLGR legislative framework** – FNLGR Regulations made, and Framework Agreement amendments enacted, along with related FNLRS regulation changes
- ❖ **Finalize privacy & information-sharing instruments** to govern how data flows between Canada, SGB and FNLGR, and how it is protected
- ❖ **Start-up operations & fees** – bank accounts opened, signatories approved, and CFA funds transferred into FNLGR accounts
- ❖ **Approve and publish the fee schedule**, and clearly communicate fee policy to First Nations and registry users
- ❖ **Configure fee collection and accounting systems**, including payment gateways, GL mapping and receipting, then run end-to-end testing
- ❖ **Complete pilot data integration**, including SGB data integration, problem-layer resolution and updated survey workflows into the registry
- ❖ **Start-up support and service processes**, including helpdesk/ticketing, triage/escalation paths and documented SOPs
- ❖ **Deliver training at scale** – training environment live, training program rolled out, with a high completion rate for pilot and early adopter First Nations
- ❖ **Confirm launch readiness with pilots and partners**, using formal readiness checklists and Go/No Go decision gates
- ❖ **Secure and align long-term funding**, including Budget 2027 and MOUs/agreements with ISC/CIRNAC and SGB for ongoing support
- ❖ **Plan for future innovations**, such as Land Records and post-launch enhancements informed by pilot experience
- ❖ **Launch Registry** for first communities and users

- Staging and Production infrastructure are in place and ready



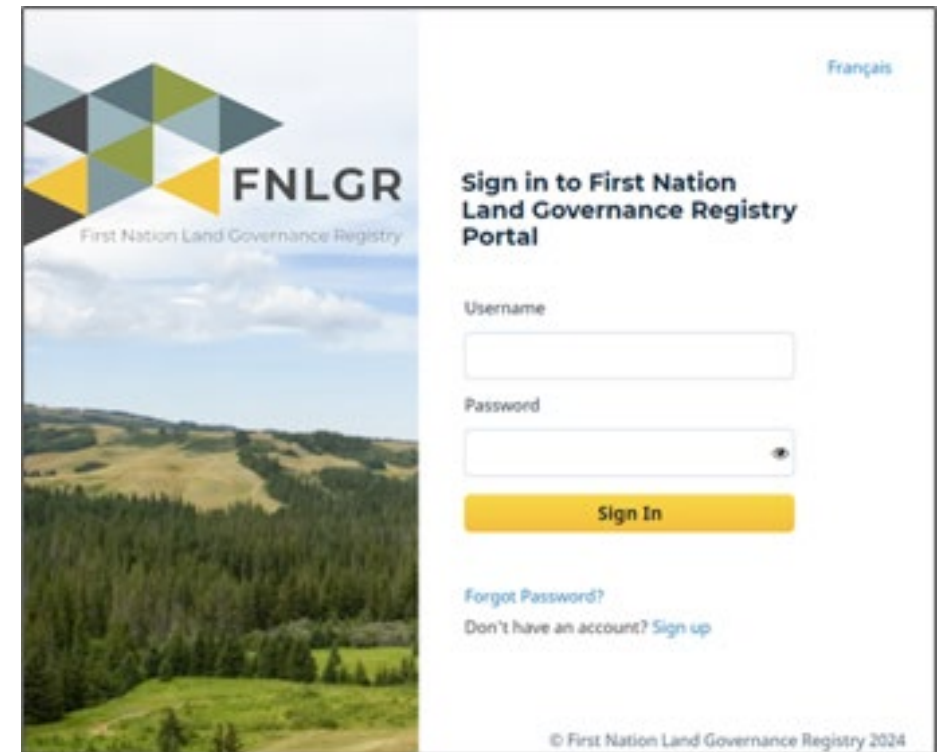

# Legislative & Regulatory Matters

To ensure independence, autonomy and economic prosperity for First Nations through FNLGR, the LABRC is asserting the following key strategic regulatory and policy positions:

## FA Amendments

- Support amendments to FA & FAFNLMA
- Enable transfer of lands from Canada's registry to FNLGR
- Enable FNLGR Regulations & amends federal FNLRS Regulations

## Registry Regulations

- Regulations drafted by LAB (not Canada)
- Cover registration processes, plans, rescinds, reserve changes
- Focus on legal clarity & operational readiness

## Privacy & Security

- Federal Privacy Act does not apply
- Regulations authorize secure info transfer from Canada
- LTSA partnership ensures advanced privacy protections
- Conduct a Privacy Impact Assessment (PIA) to advise ongoing policy development

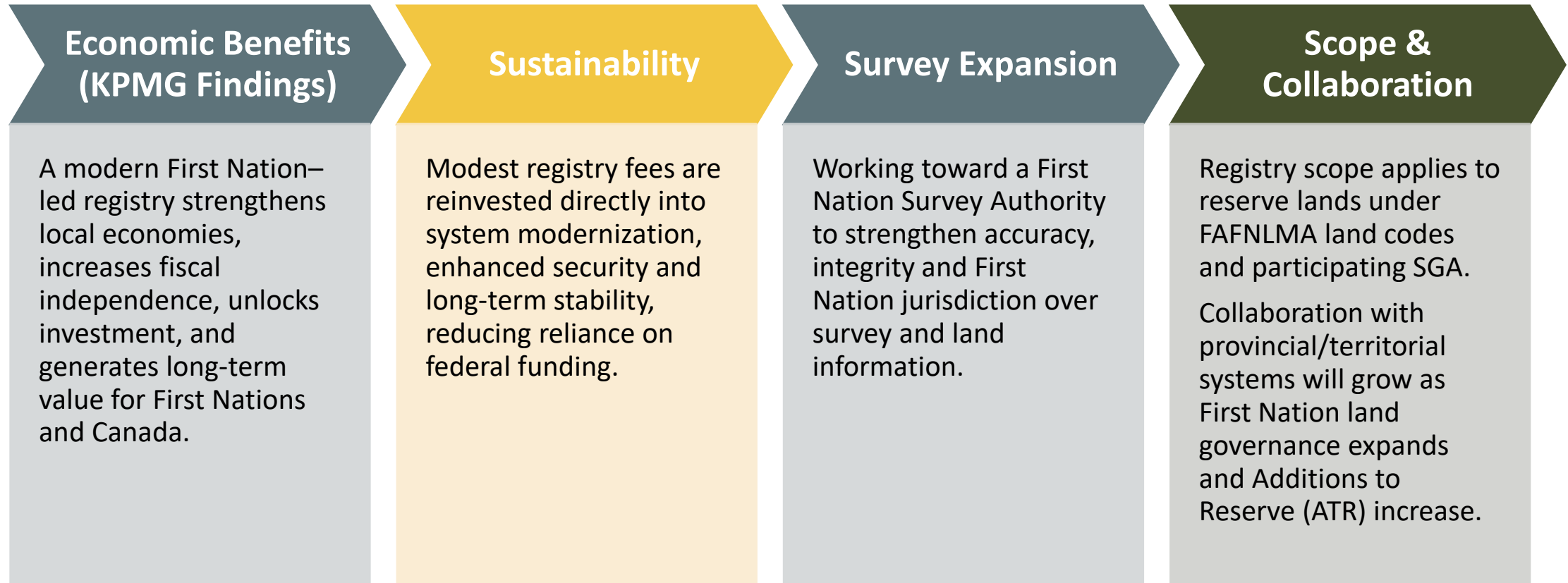
## Transitional Workplan & Onboarding

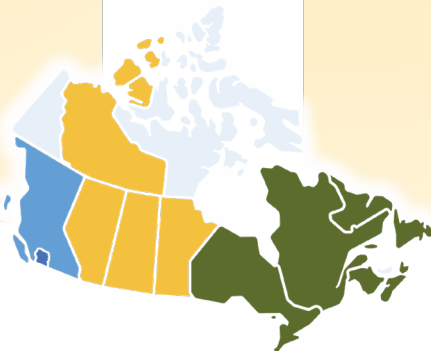
