Member	For the purposes of the "Kitselas Land Interests Law" Only a band member registered under section 6 of the Indian Act, and is a registered member of the Kitselas Band is eligible to be granted a right of possession and occupation in Kitselas lands.	
Criteria	 The following is the criteria approved in this policy: Residential lots in either Kulspai or Gitaus, Lot must be surveyed and have a recorded legal description. No money is to be owed to the band for the house. House is no longer under a mortgage through CMHC If there is to be more than one owner, both or all owners must agree to either a joint tenants to tenants in common. 	
Rights of owners	 The right of possession and occupation includes: The right to "will" the home and lot to another band member, the band cannot transfer ownership of land to a non band member. The right to sell it to another band member, To lease or rent To give it to another band member The right to benefit from the resources on the land.
