MAGNETAWAN FIRST NATION



Samantha Noganosh – Lands, Resources and Environment Manager

Samantha is a proud member of Magnetawan First Nation who works and lives in the community. She began in the Magnetawan Lands Department in 2015 as the Lands Clerk. Under the mentorship of the previous Lands Manager, Samantha had worked with various levels of Government, Ministries, industries, and proponents regarding Magnetawan First Nation Land. In 2020 she accepted the Lands Manager position. As well as her role in the Lands Department Samantha also sits as Deputy Chief in her Community bringing the foundation of her skills and experience full circle, from high level governance to on the land technical work.

MISTAWASIS NEHIYAWAK



Anthony Johnston - Special Advisor

"I am from and work for Mistawasis. I aspire to be Nêhiyawak."

Anthony is a member of and works for his Nation, Mistawasis Nêhiyawak, a Cree community north of Saskatoon, Saskatchewan. He returned to his community with the hope of contributing life, work and educational experiences for the benefit of community. He believes that his contribution has been developing and building on partnerships, alliances and friendships with good true people who care. Anthony has worked with federal and provincial governments in Saskatchewan and Manitoba. He has a BA with a History major and Human Geography minor from the University of Manitoba.

T'SOU-KE FIRST NATION



Chief Gordon Planes – Director – BC Region

Gordon's traditional name is Hya quatcha, named after his great grandfather from Scia-new, the salmon people. Elected Chief of the T'Sou-ke nation for the past 10 years, Gordon previously held a position as the Back Country Operations Manager of the West Coast Trail for Parks Canada. He is a Coast Salish carver, artist, traditional singer and a captain of T'Sou-ke traditional dug-out canoes for the last two decades.

Gordon has previously taken a three-year assignment in working with his community in bringing back their Northern Straits Sencoten language. He is actively working with the community in renewable energy, food security, cultural renaissance and Economic Development.

BINGWI NEYAASHI ANISHINAABEK



Jordon Hatton – Director of Economic Development

Jordan Hatton is the Director of Economic Development for Bingwi Neyaashi Anishinaabek (Sand Point First Nation), a formerly displaced First Nation that is in the process of rapidly developing its reserve lands on the south-east shores of Lake Nipigon. In his work with BNA, Jordan is responsible for all on-reserve infrastructure developments, housing and land management work, on and off-reserve business developments including the Papasay Value-Added Sawmill operation, forestry and mining agreements, employment and training matters, and regional, multi-First Nation initiatives, all off-reserve consultation matters, and sits on multiple Boards for the community.

As Director, Jordan is responsible for the six staff in his department, budgeting for nearly 100 projects and initiatives, and all funding applications and reporting requirements associated with these Projects. Jordan has been working with First Nations for the last 13 years in various resource development, lands and economic development-related positions. He received his master's degree in Political Science from the University of Guelph in 2008, and enjoys spending time with his partner, family and friends, travelling the world, fishing, golfing, and heavy metal festivals.

Monty Horton – Lands Governance Officer

Monty is the Lands Governance Officer for Ditidaht First Nation (DFN). Monty manages the day-to-day activities of DFN, including administering the DFN Land Code, facilitating the Lands Committee, developing training opportunities and developing Lands administration systems.

Mylon formerly served as Executive Director at a First Nation in Ontario where he led strategic direction, governance and economic development, duty to consult negotiations, and all aspects of government administration.

Born and raised in northern Ontario, Mylon holds an MA from the University of Waterloo. His diverse background extends to international development and underground mining.

Krista previously held the Operator/Environmental Officer position at WFN for just over 7 years (2002 – 2009). She then moved to Vancouver in 2009 to take a position with Indigenous and Northern Affairs Canada (INAC) in the BC Region. At INAC she worked on training programs for Operators as well as managed the Circuit Rider Training program that consists of hands-on training and mentoring for Operators who work for the 203 First Nation communities throughout all of BC.

She is actively involved with the BCWWA, PWABC and EOCP having served 2 terms on the board of Directors. She organized and hosted the annual First Nation Operators conference for 6 years, which brought together First Nation Operators from across BC & the Yukon. Krista moved back to take on her role as WFN's Manager of Utilities in October of 2016.
