


# **Overview of current Operational Funding Formula**

#### • 29. DEVELOPMENTAL FUNDING

29.1 Canada and the Lands Advisory Board will enter into a funding arrangement to allow the First Nations to develop land codes and community approval processes for their land codes, to negotiate the individual agreements mentioned in clause 6 and to seek community approval under clause 7.


#### • 30. OPERATIONAL FUNDING

30.2 A method for allocating such operating funds as may have been appropriated by Parliament will be developed by the Parties and the Lands Advisory Board.

30.3 Unless a First Nation and Canada agree otherwise, an individual agreement respecting the provision of funding under this clause will have a <u>maximum term</u> of five years and will include provisions for its amendment and renegotiation.

#### **Transitional Funding Contribution Principles**

Paid directly by Canada as a contribution through existing funding arrangements to First Nations.


This portion of operational funding is subject to individual CFA time limits for spending as well as allowable categories, reporting and claw back.


\$75K per year for 2 years in addition to operational funding.

Intended for development/legislation of high priority laws, hiring, equipment, training, systems development, planning, communications, legal instruments.








#### **Operational Funding**

- Paid directly by Canada as a grant through existing funding arrangements to First Nations.
- This portion of operational funding is not subject to time limits or claw back.
- Intended to comply with section 30 of the Framework Agreement
- Operational funding is Canada's contribution to "Manage First Nation Lands and make, administer and enforce its laws under a land code".
- Four (4) Categories of Funding: First Nations are divided into groups based on the amount and type of recorded interests in the Indian Land Registry.




### **Proposal Based Funding**







