First Nations Land Governance Influencer Award

- Framework Agreement signatory First Nations individuals or a group of individuals who are involved in land management activities within their communities.

Such individuals may include:

- Chief and or Council Members
- Lands Managers/Directors (or other lands department staff)
- Community members

Who can nominate?

Anyone can nominate an eligible business or individual for the **Framework Agreement Economic Development Leadership Award** and the **Framework Agreement Governance Influencer Award**.
